What are the Victorian Allied Health Assistant Workforce Recommendations and Resources?

The Victorian Allied Health Assistant Workforce Recommendations and Resources are designed to support you and your workplace in optimally utilising Allied health assistant workforces.

This work was funded by the Department of Health and completed in collaboration with Monash Health over the span of 2020-2022. In our previous newsletters we provided you with an overview of:

- What the workforce project is
- What the recommendations are
 How we've tested and refined the recommendations

The project team, comprising of two Allied health professionals and one Allied health assistant, has undergone an extensive consultation with research methodology to deliver recommendations and resources that meet the needs of the Victorian health, aged care and disability sectors. The final eighteen recommendations cover five key areas, each with resources to support implementation.

Pre-employment training Recommendations 1-5

Workforce planning and governance Recommendations 6-9

Consumer-centred therapy and supports Recommendation 10 **Recruitment and induction** Recommendations 11-13

Workplace training and development Recommendations 14-18

Implementation Coaching in 2023

In November 2022, after a competitive expression of interest period, six Victorian Public Health services were selected to participate in Implementation Coaching during 2023 to support their progress toward optimally utilising Allied health assistant workforces.

Our first cohort consisting of Bendigo Health and South West Healthcare have recently completed an intensive 16 weeks of implementation coaching with the project team. This coaching period was tailored to several SMART goals set in collaboration with the individual coaching candidate organisations.

Over the course of the 16 week coaching period, both South West Healthcare and Bendigo Health:

- embedded delegation training modules onto their online learning management systems
- embedded a consistent delegation process into practice
- saw an increase in their AHAs feeling their role was valued
- improved their targeted workplace training and development opportunities for AHAs.

South West Healthcare also introduced the Victorian AHA Project Consumer resource as a part of consumer engagement moving forward.

Lastly, we would like to welcome baby Alex into the project team with mum Sandy doing an amazing job and wish Jess good luck on her upcoming maternity leave. The project team thanks South West Healthcare and Bendigo Health for traversing this learning journey with the team so graciously. Sustained large scale change takes time and we are looking forward to hearing about the continued progress and achievements around optimal development and utilisation of AHAs at Bendigo Health and South West Healthcare into the future.
